Attorney Osteen said there is a procedure for Code Enforcement. He said this is handled by Mr. Steve Fremen. He said that Mr. Fremen will investigate this and send a letter if there is a violation. If the property owner does not comply then the matter goes to court.

Ms. Kelly Cox said she has complained multiple times of people living in sheds without septic or power.

Mr. Fremen said he has 140 cases for code enforcement violations.

Mr. Guy Richardson asked who enforces this.

Attorney Osteen replied code enforcement and the court/judge.

Commissioner Stephenson said you can't stop this from happening. He said you must deal with the process afterwards.

Mr. Wright said this can be handled, but it is a process to achieve compliance.

Commissioner Mills said this process must go through the court system. He referred to one specific case that has taken two years and is now going through the second appeal.

Attorney Osteen said they are waiting on an order from the judge on this.

Mr. Wright said they must have a formal complaint from the public.

Mr. Brian Kowalski spoke to the Board via telephone. He said they moved here from North Carolina. He said they will be building a home in 2023. He said they have talked to the neighbors and explained their plans. He said they are currently living at a campground.

Manager Cannon informed the Board that the jail roof contract has been fully executed and the initial engineering plans should be submitted to Building and Zoning. He said the roof should be done in April or May.

Manager Cannon informed the Board they mailed out letters to 112 landowners of the explanation and Right of Entry forms in order to gain access to Brushy Creek for the canal clean out project.

Manager Cannon informed the Board that the Road Department will start work on Monday. He said that all employees will be back from their vacation time off. He said they will begin working with the Gradeall on Monday. He said staging of sediment will be on county owned property.

Commissioner Storey asked what area will they start working in.

Manager Cannon said the Board had given the authority to the Road Department to choose the roads.

Commissioner Storey said to begin around the Guy Richardson neighborhood and then Watson Homestead.

Commissioner Mills said he would like them to start in that same area.

Commissioner Hatch said he received a call regarding tearing down a mobile home in Taylor County and dumping the C & D waste in Dixie County. He said the gentleman has offered to pay to do this.

Manager Cannon said he does not recommend the Board receive this from out of county. He said that Taylor County has their own C & D facility as well as other counties have their facility.

Commissioner Mills and Commissioner Stephenson agreed that the Dixie County landfill is already reaching capacity sooner than expected.

Mr. John Locklear recommended the Board not allow this to happen. He suggested they be conservative due to saving space for the residents.

Commissioner Stephenson said that Aucilla has a double liner and it is expensive and you must process the water from the liner and treat it like wastewater.

Ms. Jacki Johnson said that \$35.00 per ton is very cheap. She said this is part of the problem. She said it is \$67.00 in Gilchrist County or higher. She said you may need to raise the rates to help discourage this.

Commissioner Stephenson said the Solid waste Assessment will not cover the expenses. He said that Dixie County has more dump sites and a cheaper rate and more dirty roads than other counties.

Commissioner Stephenson said that Road 353 is narrow, and people run off the edge of the road. He said this needs to be widened in the future.

Commissioner Mills had nothing further to discuss at this time.

Commissioner Storey said he was sworn into this office to do the best for Dixie County. He said he has worked with several members of the Board throughout the years. He said it is hard to remain neutral. He said he must make his own decisions and be honest with the people and do the right thing. He said he will do what is best for the county. He said he will consider everything and try to make the best decision.

Mr. Guy Richardson asked if the county will be filling in the ditches and culverts for the post office. Commissioner Storey replied they will be cleaning these out.
