#### **CALL TO ORDER**

The Emergency Meeting was called to order at 5:00 PM by Commissioner Storey.

#### INVOCATION AND PLEDGE TO THE AMERICAN FLAG

The Invocation was led by Commissioner Storey and the Pledge to the American Flag was led by Commissioner Stephenson.

Emergency Management Chief Scott Garner informed the Board of the approaching Sub-Tropical Storm Nicole. He said the 4:00 PM update reflects the storm shifting west and coming in the north part of Taylor County. He said we will get 2-4 inches of rain and winds if the storm moves more towards Tallahassee. The Suwannee River is the cut off for the three-day air cone module. He said there is a cold front which is pushing the storm back to the East. He said there will be Tropical Storm Force winds on Friday.

Chief Garner requested the Board approve State of Emergency RESOLUTION 2022-167.

Commissioner Hatch made the motion to approve State of Emergency <u>RESOLUTION 2022-167</u>. Commissioner Stephenson seconded. Board approved.

Chief Garner said City Manager John Driggers Jr. is evaluating the cancellation of the Veteran's day Parade on Friday, due to the storm winds.

County Manager Duane Cannon verified that all the County Offices and the Clerk's Office will be closed on Friday. He said the schools will also be closed on Friday.

Chief Garner said they will not be opening any shelters at this time.

Commissioner Stephenson asked how fast the storm is moving.

Chief Garner replied currently at nine (9) MPH and 13 MPH by Friday. He said the Jacksonville and Daytona area will be severely affected if the storm stalls over them.

Chief Garner said the storm winds will affect Dixie County Wednesday evening and Thursday morning.

Chief Garner said they receive State calls on the weather updates at 11:15 AM and 5:15 PM daily. He said <u>STATE EXECUTIVE ORDER 2022-253</u> was being reviewed by the Governor today at 11:15 AM and he will possibly sign this.

Chief Garner said he would like to have the Clerk's Office and the County Attorney work with him to get a State of Emergency Resolution pre-formatted to use as needed for future events.

Manager Cannon asked if the renewals of the State of Emergency Resolution could possibly fall on Board Meeting dates for approvals.

Chief Garner explained how that may be possible. He said the county must renew this every seven (7) days.
