**WHEREAS**, heavy rainfall caused severe problems, including flooding and damaged roadways;

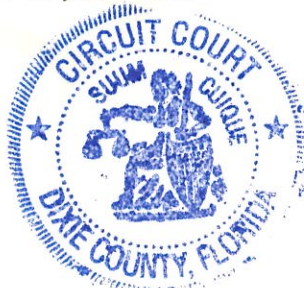

**WHEREAS**, these conditions created a need to extend the State of Emergency for a period of seven (7) days; from December 16, 2021 until December 23, 2021.


